The Reasons for This Document:

This document has been made in response to [The Dossier](#), a document containing allegations and evidence against a user who we'll refer to as "Sky." We have conducted our own investigations over the past month or so and we wanted to share our own findings.

These findings conflict with the overall narrative* The Dossier is attempting to push. While it's not completely inaccurate; we feel it's necessary to bring more pieces of the puzzle into the light so that people may be informed of what is actually happening as to prevent a senseless lynching*. So, we'll start from the beginning:

*Edit: The authors of the dossier would like to reiterate that they do not condone any harassment of Sky. This statement is largely for those going against the author's wishes. They have also walked back the pedophilia accusations (*which is the overall "narrative" we were referring to*).

You can find a screenshot of this conversation below:

In both the beginning and end of my document I make it crystal clear that Sky under no circumstance is to be harassed or doxxed or any kind of hate or targeted harassment whatsoever so I find it highly misleading to claim it as such when me and my wife made it clear from the start that we don't want sky being harassed or targeted by literally anyone. This was not your usual cancel culture attempt or a revenge prod like others are claiming as well it highly comes across as putting our credibility into question or framing us as wanting the harassment to even be happening in the first place.

I have made it clear numerous times but I'll say it again in case you do screenshot these dms (I give you full permission to do so I have nothing to hide at all) I will say it again. I do not under any circumstance approve of or condone any harassment or targeted attacks towards Sky in any capacity whatsoever and that goes includes doubly for wrongly calling her a pedophile as well which I have already made it public knowledge and have corrected.

Each and every single person is responsible for their own actions. Please do not harass others even if you think it's "morally justified" to do so. If you're going to report Sky's actions, do so in a civil way to the server's staff (*and not in the memes channel just to leave immediately afterwards*).

10/02/2023 - The First Allegations Arise:

Continuing from the information listed in “The Dossier”, the yellow anon (*I’ll refer to them as Sky’s ex from this point forward*) contacted us regarding some information they’d learned about Sky. More specifically that they’d just broken up since they were “made aware that my ex groomed me while we were together.”*

We will not be providing specific screenshots of this conversation to protect the privacy of the accuser.

However, we will post the evidence that they provided:

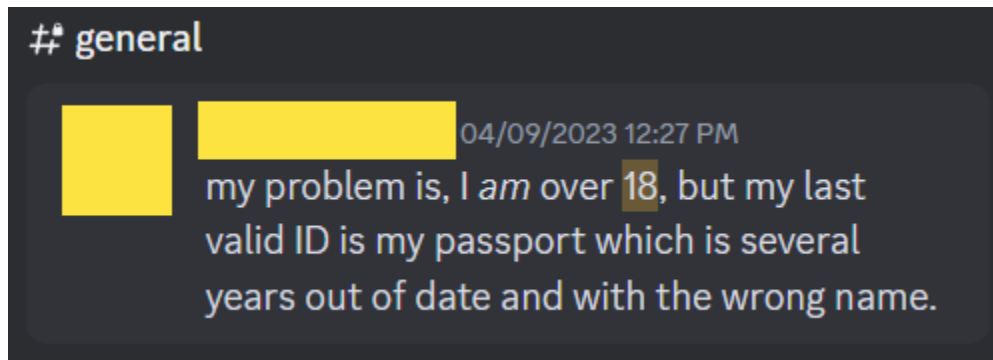

“The Dossier” excludes some of the other conversations that took place between Ashley (AshyTwi, or Rarity in these pictures) and Sky (Flutterzky, or TwilySparky).

The first two pictures are those pictures omitted from the dossier. These pictures are particularly of value because they show Ashley trying to further the relationship with Sky. Another thing to keep in mind is that these screenshots were provided by Ashley, not Sky. Though with my conversations with Sky, Sky did confirm that these were legitimate.

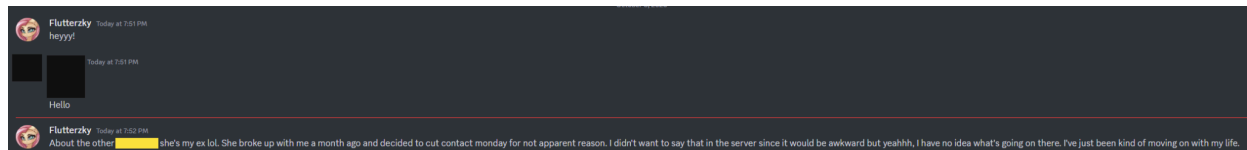
**Both users met and started dating this year (2023). Since their ex was 19 when they started dating this is something we, personally, do not consider grooming.*



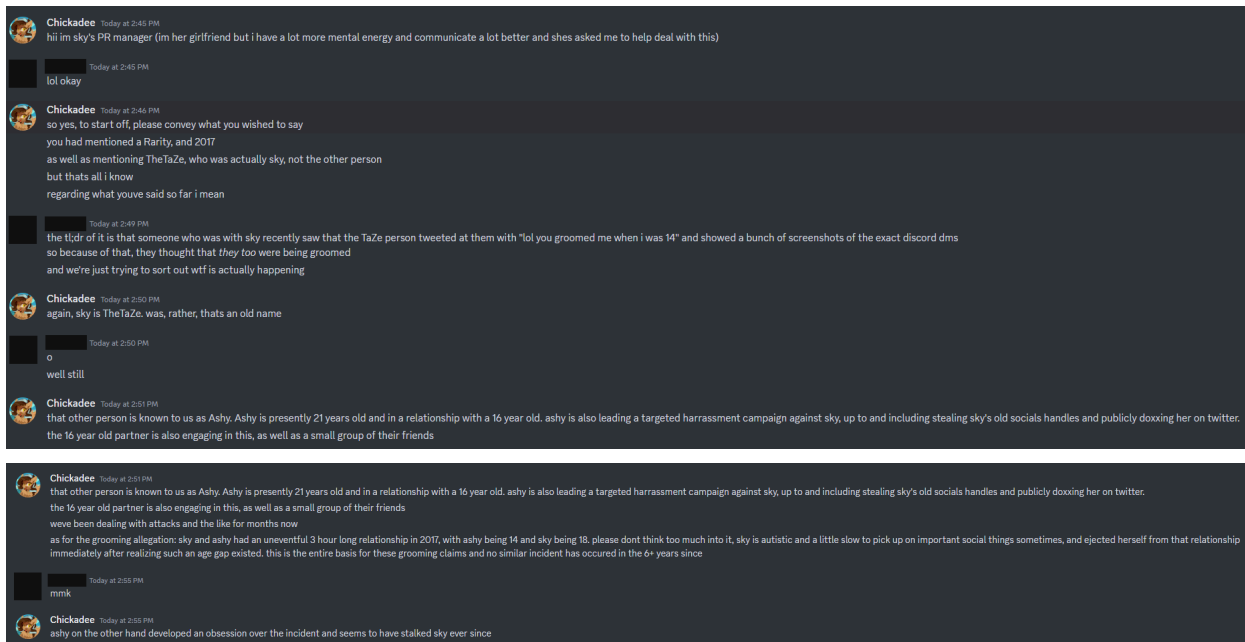
It's still possible to be "groomed" for abuse of many different forms, which is what Sky's ex has stated they meant when they reported it as grooming. We still assumed very early on that the grooming allegation was for pedophilia, but we'll cover that in the rest of this document.

10/05/2023 - Concerning Behavior:

Sky becomes suspiciously active in our community. Due to the allegations and their ex being on our staff team we feel there's a few red flags. Sky and their ex appear to know each other, so one of our staff members does a little digging.



More digging is done on our staff's end to link certain accounts together. Regardless of Sky's actions we're not in favor of continuing what we feel is a witch hunt against Sky, so we'll be keeping any additional profiles we've found private.



(Pictures of allegations against Ashley/AshyTw, which we verified through other servers.)

Sky's current girlfriend (*Chickadee*) then contacts the above mentioned staff member to try to clear a few things up. At this point the information on both sides was still rather opaque, it seems like both sides are accusing each other of pedophilia and a lot more work is needed to get the truth.

10/12/2023 - Application for Helper:

Sky applies for Helper in our community. Due to the allegations and the lack of a meaningful conclusion by this point many of our staff question why the application was sent in. Even more information is dug up as a result. We look extensively at their social media profiles for anything that could be remotely incriminating, but we don't find much.

What I did find, however, is a statement from 6/29/2020 when the proposed Aryanne ban stuff was happening. I'll paraphrase it: "It's shocking how Derpi banned Aryanne but isn't banning gross shit like foalcon or incest." This was 3 years before any of the allegations surfaced, so I don't think it's Sky trying to do "PR" for themselves, so to speak. Most pedophiles support foalcon unconditionally, so Sky bashing foalcon doesn't really scream "pedophile" to me.

I do find other statements that back the general "4chaner" notion (~~though this particular concern is silly, many people in the fandom are former if not current 4chan users~~ Edit: statement redacted. More on that in "Exhibit C"), as well as a few comments that seem to oppose the shutting down of the one Nazi art pack. Otherwise, no recent support has been seen of Nazis, so we didn't consider it action-worthy.

10/13/2023 - Social Media Digging:

We looked into Sky's social media profiles more and found an account that appears to be doxing Sky. Phone numbers, parents, voter ID, full name, email, date of birth. Whether or not this information was legit is up in the air, but Sky stated most of it was inaccurate. Either way, this account is traced back to Ashley (or AshyTwi). The doxing is reported to Twitter, but it apparently doesn't violate their ToS (*Twitter sucks*).

Even if you think a person is in the wrong, don't dox them. Take it to the authorities if you really have an issue. Twitter isn't the proper place to make action happen. At least to us the way Ashley has been acting at the age of 21 feels like they're being extremely dishonest.

Regardless, it's at this point that I also contact some other communities to see if they've had any issues with Sky. There was a mixup between Sky and Ashley, but otherwise I didn't hear any concerns. This is also where I confirm Ashley/AshyTwi's current relationship with a minor.

It's at this point that we have a solid bottom line; Sky (*18 at the time*) had a "relationship" with Ashley (*14 at the time*) in 2017. Ashley has engaged in acts that (*at least with the information we have*) are worse* than what Sky has done. Ashley may have done this because of the brief relationship Sky had with them (*effectively normalizing it for them*), though we believe Ashley may just have a thing for large age gaps at this point. This is something other communities have noticed, and since Ashy's getting in trouble for it it may explain why they have such a recently found vendetta for Sky.

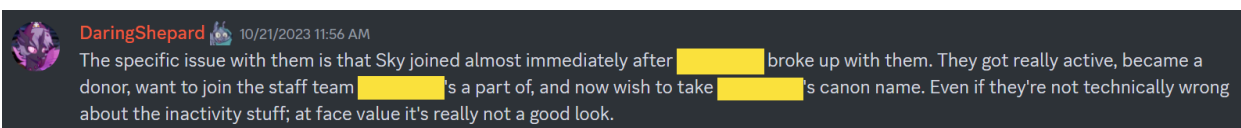

10/15/2023 - Concerns of Being Watched:

Sky makes a comment that they feel certain staff members are watching them. No other notes on this day.

10/21/2023 - Canon Roles:

Sky asks about a canon role that belongs to their ex. The red flags start to show again since we feel it may be targeted.


Feeling like things are at a tipping point again, we ask their ex for additional details. We're looking for recent conduct regarding pedophilia or anything that may be seen as it. One of the pieces of evidence presented for this was an alleged quote from Sky stating that "teens are horny."

After digging into it further there wasn't enough evidence to sway things in one direction or the other. When I eventually confronted Sky about that specific quote they didn't remember too much about it, though in their defense neither did those accusing Sky.*

10/23/2023 - The Confrontation:

Today is the day I confronted Sky about the allegations in a private voice channel on our server. I'll post my summary below:

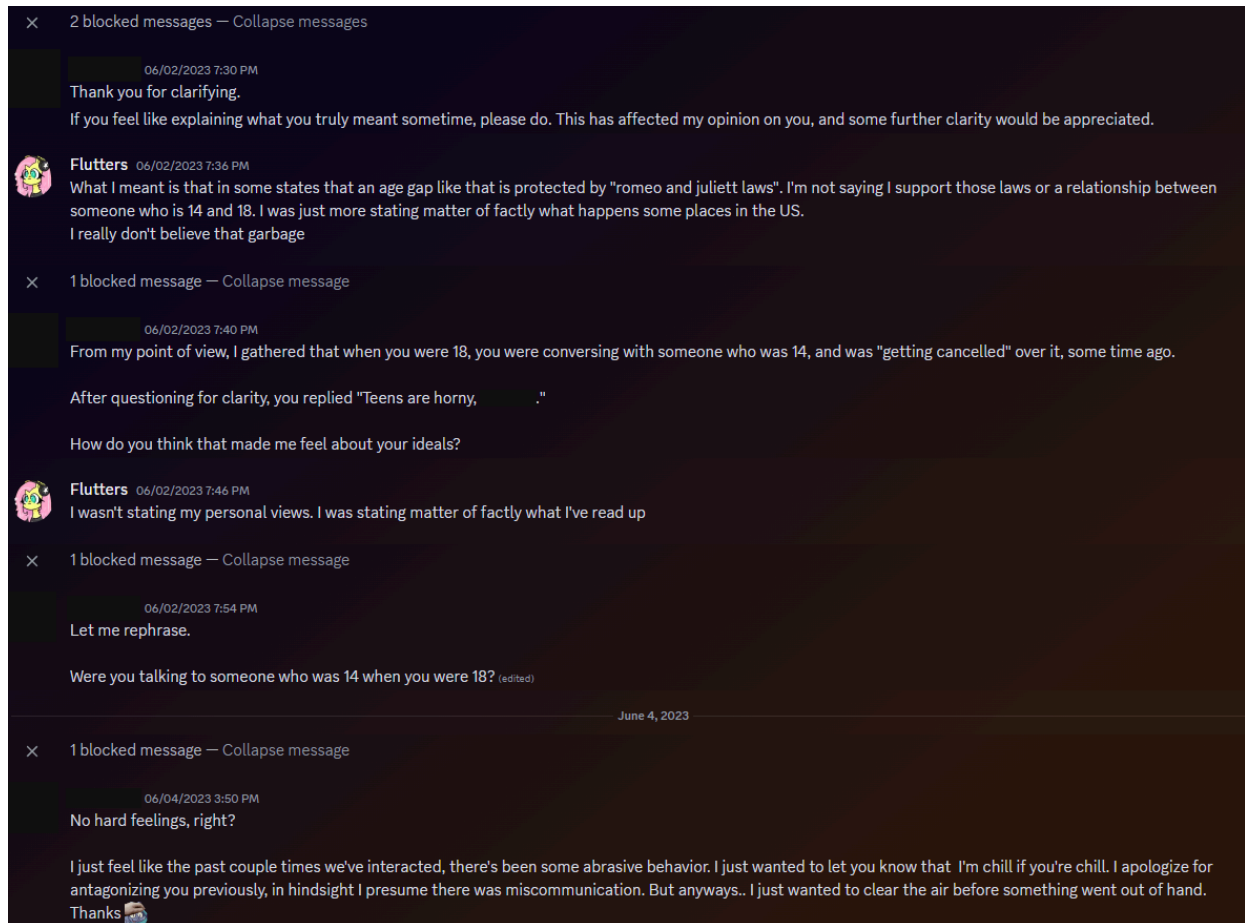

As far as their own statements go, they did again admit to the relationship with a 14 year old while they were 18, and that this person was Ashy/AshyTwi. They claim that they weren't aware of their age and immediately ceased communication after they learned their age. Considering Ashy hasn't posted anything beyond those initial messages I'd consider this an accurate statement. They'd have more to show, otherwise. Ashy has also allegedly deleted all of those messages they had with Sky. It's not unheard of, but usually the offender is the one to try to cover up evidence.

The conversation Ashy posted on Twitter was confirmed as legitimate by Sky: [#mod-chat](#) And it was stated that Ashy had tried to use this information to blackmail Sky into getting staff in Sky's community. From what I can tell based on Ashy's actions, it very much seems like they're angry that they were caught and Sky wasn't, but I digress.

I brought up the specific concern mentioned regarding the comment that was made in a VC, though I wasn't really able to get much out of it. Seems to have been mostly a restatement of what they told . I believe they mentioned that conversation was largely about Ashy (*obviously, due to the messages*), but I can't recall any noteworthy specifics beyond that. They also gave the full conversation they had with :

While we don't believe this was maliciously left out, something we feel is noteworthy is the fact that the accusers left out the June 4th message from the evidence they sent our way. This message, at least to us, makes it seem like the issue was resolved. Leaving it out removes context that would have otherwise been important to our investigation.

Regardless, we were looking for any kind of indication that they either defended their actions, shrugged it off, or had any indication that they did it again after the initial incident. We didn't find anything to suggest that.

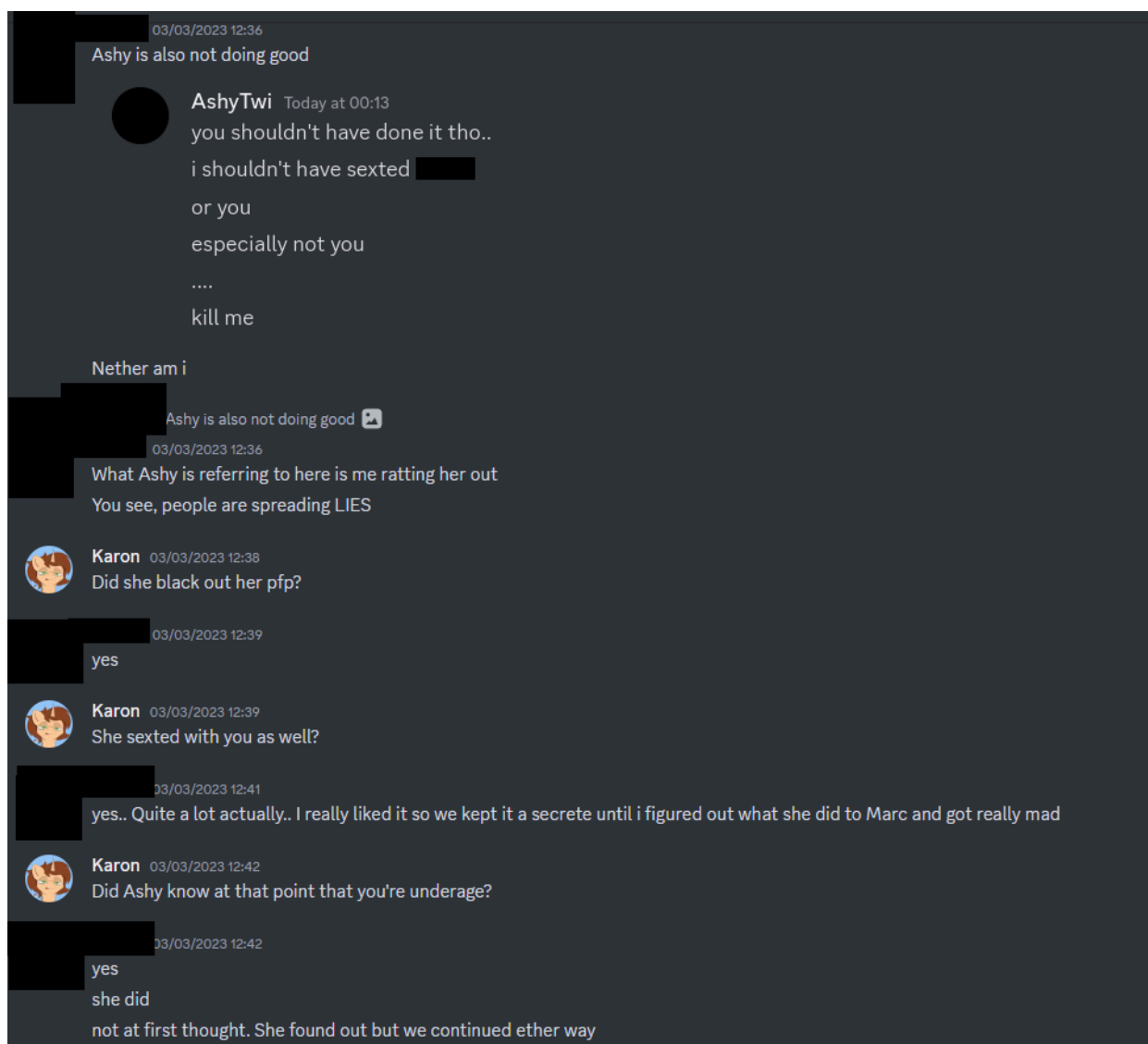
In my conversation with Sky on this date I had advised them to wear the incident on their sleeve for a bit if they truly were sorry and wanted Ashley to stop holding it over their head. It took a bit for this to happen and was likely "nudged" a bit by the dossier being posted, but the fact of the matter remains that they still acknowledged it publicly and have apologized for it.

Our Conclusion:

On “Exhibit A” of the dossier:

Sky should have asked for Ashley’s age before accepting nudes, but they didn’t. That’s the bottom line, and it can’t be overlooked. This doesn’t mean that anyone should ignore the fact that this has not happened again since 2017, either. It was one horrific incident that Sky appears to have learned from. Every time Sky has been confronted on the subject they have fully admitted to it and apologized for their conduct.

Meanwhile, Ashley and the minor they’re currently dating are leading a massive campaign against Sky. Largely speaking it appears to be projection, and many of our staff are calling it a “witch hunt” as a result. What happened to Ashley sucks, but you cannot criticize Sky without having *even more* outrage for Ashley. Sky appears apologetic for their actions. Ashley is vindictive, vengeful, and is actively engaging in pedophilia.



(Ashley has also gone by the name “AshyTwI.” The above picture is from a victim’s DMs accusing Ashley/AshyTwI of sexting a minor while knowing the minor’s age, which has been verified by multiple communities.)

Exhibit B:

I cannot comment much on the emotional abuse allegations since this was beyond the scope of our investigation, but Sky has confirmed that the feelings that the ex had are “true to a point” via their Twitter. Pictures of this can be found at the bottom of the document.

Exhibit C:

Edit: A source we trust has come forward with more evidence on this specific section and I'm redacting our statements below as a result.

They shall still be kept in the name of being transparent, however, but in the name of honesty we are obliged to post the objective truth as we see it.

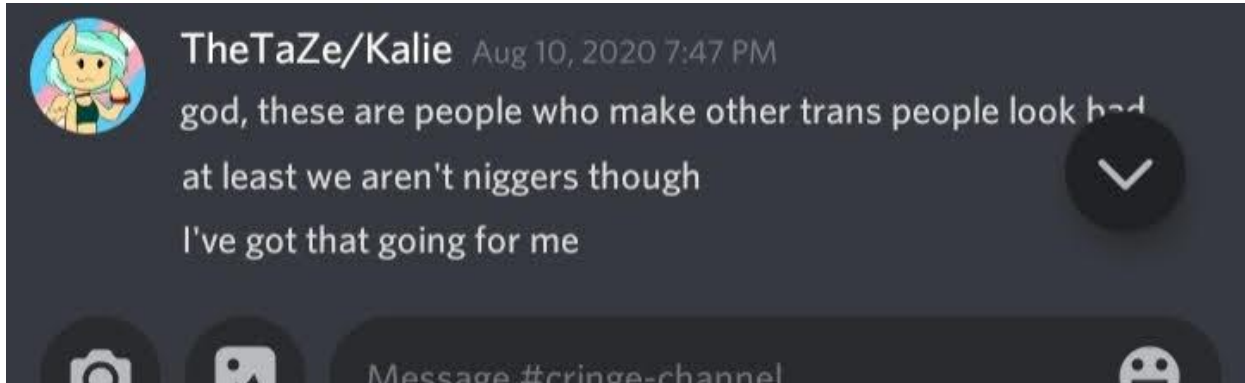

While it may have happened a few years ago at this point, it's pretty damning evidence considering the other connections they appear to have had up until recently.

Redacted statement:

For the most part being a 4chan user isn't really a crime. If we were to ban every person who used the site even once we likely wouldn't have a server. I can understand the concerns of having a friend with an Aryanne profile picture, as well as the concern about being in a Steam group with Aryanne also in the icon, but as far as we can independently verify they are neither in this group, nor are they friends with the user who had the Aryanne profile picture.

Admittedly both of these things could have been corrected after the dossier was posted, but since we can't independently verify it and it seems like the dossier has some holes in it, anyway, we feel that the information may be inaccurate.

If nothing else, Sky is now taking steps to distance themselves from that side of the fandom, and we believe that this is a good thing.

Overall:

At no point in my investigation did I see any reason to reasonably suggest that Sky has repeated their behavior ever since the initial 2017 incident with Ashley. Everything else I have witnessed with my own eyes suggests that Sky does not care for pedophiles or even foalcon, a thing that pedophiles usually attempt to defend. These criticisms of pedophilia and foalcon come before many of these allegations surfaced, so I have little reason to believe that they may have been done for “PR” reasons.

We would remove them from our community if we felt there was a legitimate safety concern for others. As of the current moment in time we have little reason to suggest there may be any legitimate safety concerns.

Edit: It should also be stated that this document largely has been made to address the grooming/pedophilia allegations. Anything else was largely beyond the scope of our investigation.
